Observed fridgeration at 33F. Observed ice cream cooler at -16F. Observed Safeserv present. Observed hot holding temps at 135F and cold holding temps at 38F. No food preparation observed at time of inspection. Observed boxes placed on floor of freezer, manager states still in the process of putting away recent delivery.
