Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.</p>
<p>Violation #56. Ventilation & lighting Air conditioning unit in dry storage is leaking at door. Work order on file. CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
