Observed raw ground beef above 41 degrees in walk-in cooler. Manager states they were prepping for lunch and breakfast service had started. Beef was immediately returned to walk-in cooler. Re-test was 46 degrees. Ensure PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F. (CORRECTED)

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #50. Hot & cold water available; adequate pressure

Observed bathroom sinks and two handwashing sinks missing hot water. Ensure the water source shall be of sufficient capacity to meet the peak hot and cold water demands of the establishment and provide water under pressure.
