Observed white and strawberry milk above 41 degrees on line. Adjacent milks were below 41 degrees. Also observed ice blanket on top of milk. Ensure PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F. Employee discovered the cooling machine was not turned on. (CORRECTED)
