General Comments

Observed hot holding- cheese sauce 135 F, beef 149F, chicken 155 F. Icecream freezer -2 F, milk 40F. Freezer -10 F, fridge 38 F. Observed proper thawing of cheese sauce and ground beef in walk in cooler. Observed hot water for handwashing reaches only 89 F and took greater than a minute to reach that temperature.
