<p>Violation #22. Cold holding temperatures Left over ham and cheese wraps on line at 46F. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #46. Slash resistant/cloth gloves used properly Ventilation hood is currently not working. CODE REFERENCE: 64E-11.003(2). Slash-resistant and cloth gloves used properly.</p>
<p>Violation #51. Plumbing installed; proper backflow devices 3 compartment sink leaking at all faucets. Hand wash sink leaking in store room. CODE REFERENCE: 64E-11.003(5)(c). Plumbing will be installed and maintained to comply with plumbing requirements, including backflow prevention devices. A mop sink will be provided.</p>
