<p>Violation #47. Food & non-food contact surfaces Observed dirty in ice machine. Manager cleans machine and disposed of ice that may have touched the dirt.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
