<p>Violation #15. Food separated & protected; Single-use gloves Apples in cooler on tray. Foods that are consumed with skin intact have to be covered to prevent cross contamination. Corrected during inspection. CODE REFERENCE: 64E-11.003(2). Foods shall be stored and handled to prevent cross-contamination. Raw animal foods shall be separated from RTE food and from other raw animal food during storage, preparation, holding, and display. Single-use gloves shall be used for only one task and purpose and discarded when damage occurs or the task is interrupted.</p>
<p>Violation #36. Thermometers provided & accurate Stem thermometer reading low. Adjusted and confirmed accurate upon inspection. CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #41. Wiping cloths: properly used & stored Sanitizer used for tables in dining room is 0. All sanitizer bottles taken out of service to be refilled after lunch service. CODE REFERENCE: 64E-11.003(2). In-use wiping cloths shall be stored in an effective and approved sanitizing solution between uses.</p>
