Observed food tray with sliced ham and turkey above 41 degrees. Employee stated they were thawed in the refrigerator and she is draining the excess water from the packaging. She stated the meat has been outside for 35 minutes. Ensure PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
