Observed celery with expiration date 10/3/2023. Spoke with food manager. Celery has been removed and disposed of. COS.  
CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are RTE and held refrigerated for more than 24 hours, shall be properly date marked unless otherwise exempted.

**General Comments**

Sanitizer at 100ppm. Instructed food manager to dump and refill sanitizer. Sanitizer must be at 200ppm or above. Observed celery with expiration date 10/3/2023. Spoke with food manager. Celery has been removed and disposed of. COS. Observed fridge temp at 34F and freezer at -17F. Observed meatball sandwich on line at 139F. Observed fine sediment coming out of hand wash sink on hot line. No other violations.
