Program Description

Students learn to diagnose malfunctions, repair, adjust or replace parts of the automobile, restoring it to the conditions and specification recommended by the manufacturer. These services range from basic automotive maintenance to the latest computer controlled units.

Program Requirements

The State of Florida requires students to meet the basic skill level requirement prior to program completion. The basic skills grade levels for this program are: Math: 10, Communications: 9.

Completion Requirements
