# What is Title I?

Title I is the nation's leading federal program for public schools. The goal of Title I is to help every child receive a highquality education. Schools qualify for Title I based on economic data for the students served by the school. Title I schools receive additional federal funding to fund programs and activities that improve student achievement. As a Title I school, we work to ensure we

- Provide state-certified teachers;
- Increase student performances; and
- Inform parents of our state assessment results, teacher qualification, and involvement opportunities.

# State-Certified Teachers and Your Right to Know

The Every Student Succeeds Act (ESSA) of 2015 requires school districts which receive Title I funding to notify parents of their right to know the professional qualifications of the classroom teachers who instruct their child. As a parent of a student at Suncoast Elementary School, you have the right to know if your child has been assigned or has been taught for four of more consecutive weeks by a teacher who is not state-certified. The Every Student Succeeds Act says a state-certified teacher is one who:

- Has obtained a Bachelor's degree;
- Has demonstrated competency in the subject areas assigned to teach;
- Has obtained full state certification as a teacher of has passed the state teacher licensing examinations; and
- Has not had certification or licensure requirements waived on an emergency, temporary, or provisional basis.

In addition to the state-certified teacher requirement, all paraprofessionals have an Associate's degree or have passed the Para-Pro test.

Please Note: If your child has been taught for four consecutive weeks by someone who is not a state-certified teacher, the school will send home a letter notifying you who is filling the position.
